PROCESS

Introductions with Allen were provided (absent at first meeting)

• DLR Group facilitated this meeting. As an update, the District is hiring a project manager, but the original RFP process only resulted in a single proposal, so the RFP was issued and more consultants contacted. Five (5) proposals were received in this second round. These will be evaluated with the intent to make an award recommendation to the Board on 1/23/17. It is the intent that future meetings will be facilitated by that firm.

BUDGET

- A budget summary sheet was provided at the meeting (attached) and reviewed.
- The District priority list was not provided but is attached to this summary. There is slightly less than \$475K in unallocated funds. As projects are completed and unused funds re-distributed back to the unallocated line item, there may be other opportunities to address more needs. It is recommended that no additional projects beyond those identified in the budget summary be accomplished till the high school construction is mostly complete, so as to minimize risk.
- A question was raised that if at least 85% of the bond funds must be spent in the first 3 years, how long does a district have till they spend the remaining 15%? ACTION: DLR Group will find this answer.



DESIGN PROGRESS DOCUMENTS

The approved Schematic Design package was reviewed in the meeting and previously provided to the CAC digitally.

SCHEDULE

The overall bond schedule was provided and reviewed. Of note, the security improvements at 3 of the sites has pushed back till security improvements are bid out on the high school, so the same system can be implemented at the other three sites. Additionally, the Oaklea Mechanical improvements were pushed out till the ESCO audit can be completed and the seismic rehabilitation grant determination can be made

- The ESCO (energy services contract) is outside the bond but will influence the planned mechanical improvements. The RFP was issued, and two responses were received. These will be evaluated, and an award is expected at the 1/23/17 Board Meeting.
- The SRG (seismic rehabilitation grant) for the Oaklea Gym was turned in, but the award time
 frame has been extended by the State, so no word as yet whether Junction City SD will be
 the recipient of those funds (also outside the bond, but also influencing the work at Oaklea).

COMMUNICATIONS

The group thought that the District should communicate out when any company or individuals are used / hired from Lane County. **ACTION:** DLR Group to discuss and coordinate with District. Methods discussed:

- District Website
- Facebook
- Newsletters
- Chamber (quarterly)

The group also thought that each project (big or small) should be celebrated and sued as an opportunity for community outreach.

Current suggestion is to hold the 3/15 CAC meeting at Territorial and instead use it as a night to celebrate the completion of the play shelter and talk about what is coming up next. It will need advanced publicity. **ACTION:** DLR Group to discuss and coordinate with District.

NOTES

- 1) We would recommend that security and ADA for three sites be issued as a single bid package for contractor interest and cost efficiency. These can be broken out by site post-bid and budgets between sites re-aligned based on bid results.
- 2) We would recommend security and ADA improvements at JCHS be combined with the larger project for cost efficiency and coordination
- 3) The green highlighted projects were added with the increased revenue stream but are still compliant with the overall bond title wording. Until that scope and approach is more clearly defined, no design fees have been negotiated, only a budget reserved.
- 4) The yellow highlighted budget were existing projects that have had their budgets increased for a more comprehensive scope at those systems and areas. The design budgets, but not fees, have been increased at these until scope is more clearly defined.
